

Gambaran pelaksanaan pengendalian barang umum di unit logistik Rumah Sakit Yadika Pondok Bambu tahun 2011

Abstrak

Pada tahun 2011, terdapat permasalahan di unit logistik Rumah Sakit (RS) Yadika Pondok Bambu, antara lain ketidaksesuaian antara data fisik dengan data tertulis, terdapat penumpukan beberapa jenis barang umum, dan terdapat kekosongan beberapa jenis barang tersebut di gudang logistik. Hal tersebut terkait dengan fungsi pengendalian barang umum logistik dimana fungsi pengendalian logistik seharusnya dapat dilaksanakan dengan baik agar tercipta efisiensi dalam penyelenggaraan kebutuhan barang umum logistik untuk mendukung pelayanan kesehatan di RS.

Berdasarkan kondisi tersebut, dilakukan penelitian kualitatif untuk menggambarkan pelaksanaan pengendalian barang umum di unit logistik RS Yadika Pondok Bambu. Hasil penelitian menunjukkan bahwa gambaran pengendalian barang umum logistik sudah cukup baik. Namun, masih terdapat kekurangan pada kegiatan pencatatan, proses pengadaan, proses pendistribusian, dan proses penghapusan barang umum logistik. Untuk kedepannya, unit logistik RS Yadika Pondok Bambu sebaiknya melakukan pencatatan secara day to day, membuat surat perjanjian kerjasama dengan supplier, memperbaiki koordinasi dengan unit lain, dan melakukan penghapusan dengan rutin bila diperlukan.

<*i*>In 2011, there were problems in the logistics unit of Yadika Pondok Bambu Hospital, namely discrepancies between the physical data with written data, there was a buildup of some kind of public goods, and there were several types of goods are gaps in warehouse logistics. This is related to the control functions of public goods logistics where logistics control functions should be implemented properly in order to create efficiencies in the operation of public goods logistics requirements to support health services in hospitals.

Under these conditions, conducted qualitative research to describe the implementation of the public goods control in logistics unit in Yadika Pondok Bambu Hospital. The results showed that the overview of public goods control in logistics unit is good enough. However, there are still deficiencies in record keeping activities, the procurement process, distribution process, and public goods logistics process of elimination. For the future, the logistics unit in Yadika Pondok Bambu Hospital should keep recording for day to day, made a cooperation agreement with suppliers, improving coordination with other units, and perform the routine removal when needed.</*i*>
