### Abstrak

Praktek Kerja Profesi Apoteker di PT. Zenith Pharmaceuticals bertujuan untuk mengetahui dan memahami penerapan aspek-aspek Cara Pembuatan Obat yang Baik (CPOB) di industri farmasi dan memahami tugas dan peran profesi Apoteker di industri farmasi serta mendapatkan pengalaman praktis di lapangan. Melalui praktek kerja ini, apoteker dapat melihat secara langsung kegiatan Produksi, Quality Assurance, Quality Control, Pengembangan Formula, dan teknis di PT. Zenith Pharmaceuticals. Praktikan ditempatkan di Departemen Research and Development (RnD) dan diberikan tugas khusus yang berjudul Studi Praformulasi Tablet Metformin Hidroklorida Extended Release. Tugas khusus ini bertujuan untuk membuat produk copy baru metformin hidroklorida extended release (XR) dengan formula yang sesuai dengan produk inovator dalam rangka memenuhi permintaan pasar farmasi. Berdasarkan hasil studi literatur dan analisis terhadap produk innovator maka digunakan HPMC tipe Methocel K100M Premium sebagai matriks tablet dengan konsentrasi 30% dengan metode pembuatan kempa langsung. Dengan ini diharapkan dapat dihasilkan tablet sesuai dengan target spesifikasi yang telah ditetapkan.
