Abstrak

Praktek Kerja Profesi Apoteker Di Direktorat Pengawasan Produksi Produk Terapeutik dan PKRT Badan Pengawas Obat dan Makanan Republik Indonesia bertujuan untuk meningkatkan pemahaman calon Apoteker tentang peran, tugas pokok dan fungsi Badan POM RI secara umum dan Direktorat Pengawasan Produksi Produk Terapeutik dan Perbekalan Kesehatan Rumah Tangga (PKRT) secara khusus. Penulisan laporan dilakukan dengan metode observasi langsung dan studi literatur. Tugas khusus yang berjudul Strategi Pengawasan Produksi Obat Ilegal di Indonesia bertujuan untuk mengetahui profil obat ilegal yang diproduksi dan diedarkan di Indonesia dan mengusulkan strategi kepada Badan POM RI dalam rangka menekan produksi dan peredaran produk obat ilegal di wilayah Indonesia.
