

## Laporan Praktik Kerja Profesi Apoteker di Pedagang Besar Farmasi (PBF) Tramedifa Jl. Cipinang Muara I No. 23C, Pondok Bambu, Duren Sawit, Jakarta Timur Periode 18 Februari - 28 Maret 2013

### Abstrak

Praktik Kerja Profesi Apoteker (PKPA) di PBF Tramedifa dilakukan selama enam minggu. Pelaksanaan PKPA ini bertujuan memberikan pemahaman kepada mahasiswa calon Apoteker mengenai peran seorang Apoteker di suatu PBF. Selain itu, juga bertujuan untuk memberikan pemahaman mengenai penerapan aspek manajemen pengendalian persediaan farmasi secara nyata di PBF. Apoteker di PBF Tramedifa memegang peran penting sebagai penanggung jawab pelaksanaan dan pengawasan kegiatan operasional PBF, pembuat keputusan dan peraturan yang menjamin terselenggaranya kegiatan distribusi yang baik, serta sebagai pemimpin dan komunikator dengan pihak-pihak lain yang terkait dengan kegiatan operasional di PBF tersebut.

Tugas khusus yang diperoleh selama PKPA bertujuan untuk mengkaji penerapan aspek Pedoman Teknis Cara Distribusi Obat yang Baik (CDOB) di PBF Tramedifa sebagai persiapan untuk memperoleh sertifikat CDOB. Aspek CDOB yang dibahas adalah aspek pada bab 1 - bab 3, yaitu mengenai manajemen mutu; organisasi, manajemen, dan personalia; serta bangunan dan peralatan. Hasil kajian menunjukkan bahwa belum seluruh poin dari ketiga aspek CDOB tersebut yang telah terpenuhi di PBF Tramedifa.

Pharmacist Internship Program at Tramedifa Pharmaceutical Distributor of Drug Product was conducted for six weeks. This program was intended to give an understanding about Pharmacist's role in a Pharmaceutical Distributor field to the Pharmacist rookie student. Also to give comprehension about the implementation of pharmaceutical supplies control management markedly at Pharmaceutical Distributor. Pharmacists at Tramedifa Pharmaceutical Distributor of Drug Product are responsible for executing and supervising operational activities, being a decision and regulation maker to guarantee the implementation of good distribution practice, also act as a leader and communicator to those who are involved with the operational of this distributor.

Specific assignment that student had during the internship was aimed to review the implementation of Good Distribution Practice aspects at Tramedifa Pharmaceutical Distributor as one step of preparation to obtain Good Distribution Practice certificate. Studied aspects were taken from chapter 1 - 3 according to Good Distribution Practice, which was reviewing about quality management; organization, management, and personnel; and equipments and buildings. Review result showed that not yet entire points of those three aspects were fulfilled at Tramedifa Pharmaceutical Distributor.
