Abstrak

Praktek Kerja Profesi di Apotek Kimia Farma bertujuan mengetahui dan memahami tugas, fungsi dan peran seorang apoteker di Apotek Kimia Farma. Kegiatan ini dilakukan di Apotek Kimia Farma No. 50 Jl. Merdeka No. 24, Bogor. Dalam hal ini, diharapkan apoteker dapat mengetahui dan memahami cara pengelolaan apotek dalam kegiatan administrasi, manajemen keuangan, pengadaan, penyimpanan, dan penjualan perbekalan farmasi serta mempraktekkan pelayanan kefarmasian di apotek sesuai dengan peraturan perundang-undangan dan etika yang berlaku dalam sistem pelayanan kefarmasian di Indonesia. Pelayanan kefarmasian merupakan bentuk pelayanan dan tanggung jawab langsung profesi apoteker untuk meningkatkan kualitas hidup pasien. Tugas khusus berupa analisis resep pengobatan Hiperlipidemia pasien yang dibeli di Apotek Kimia Farma no. 50 Bogor. Akumulasi terjadinya Hiperlipidemia beberapa dekade terakhir menunjukkan adanya keterkaitan dengan angka kejadian penyakit jantung koroner (PJK) yang merupakan penyebab utama (16%) dari total kematian penduduk Indonesia. Analisa resep meliputi pengkajian keabsahan dan kerasionalan resep berdasarkan skrining resep pengobatan Hiperlipidemia.

Apothecary internship at Kimia Farma Pharmacy aims to know and understand the duties, functions and role of a pharmacist in the Apotek Kimia Farma. This activity is conducted in Apotek Kimia Farma No. 50 Jl. Merdeka No. 24, Bogor. In this case, pharmacists are expected to know and understand how to manage a pharmacy in administration, financial management, procurement, storage, and sale of pharmaceuticals and pharmacy services in pharmacy practice in accordance with the laws and ethics in the pharmaceutical care system in Indonesia. Pharmacy services is a form of service and professional pharmacist directly responsible for improving the quality of life of patients. The specific task of analysis, prescription medications purchased in Hyperlipidemia patients at Apotek Kimia Farma No. 50 Jl. Merdeka No. 24, Bogor. Accumulation of the Hyperlipidemia few decades suggests there is a correlation with the incidence of coronary heart disease (CHD) is the leading cause (16%) of the total deaths of Indonesia. Analysis includes prescription and rational assessment of the validity of a prescription medication prescribed by screening Hyperlipidemia.
