Abstrak

Praktek Kerja Apoteker di Apotek Kimia Farma No. 50 bertujuan untuk mengetahui dan memahami kegiatan kefarmasian yang dilakukan di apotek, selain itu agar apoteker dapat memahami tugas, fungsi, dan peran Apoteker dalam pengelolaan sebuah apotek. Kegiatan Kefarmasian yang dilakukan di Apotek meliputi kegiatan teknis kefarmasian (pengadaan barang, penerimaan barang, penyimpanan barang, dan penjualan) maupun kegiatan nonteknis kefarmasian (kegiatan pada bagian keuangan dan bagian administrasi seperti pencatatan atau administrasi harian dalam bentuk pembuatan laporan harian). Apoteker Pengelola Apotek (APA) berperan dalam menentukan kebijakan pengelolaan apotek, serta melaksanakan fungsi pengawasan dan pengendalian terhadap semua komponen yang ada di apotek, disamping melaksanakan fungsinya sebagai seorang apoteker untuk menjamin penggunaan obat yang rasional.

Tugas khusus yang diberikan berjudul analisa resep pengobatan hipertensi di apotek kimia farma No. 50 Bogor. Tugas khusus ini bertujuan untuk mengkaji kerasionalan resep pengobatan hipertensi serta agar apoteker dapat mengetahui dan memahami peran apoteker dalam mengkaji kerasionalan resep pengobatan hipertensi. Berdasarkan hasil skrining resep ditinjau dari aspek persyaratan administratif, kesesuaian farmasetik, dan pertimbangan klinis, resep pengobatan hipertensi secara umum dinilai telah rasional.

Apothecary Internship in Pharmacy Practice Kimia Farma. No. 50 aims to identify and understand about the activities in pharmacy drugstore, besides that Apothecary can understand the duties, functions, and the role of Apothecary in the management of a pharmacy drugstore. Pharmaceutical activities that conducted in Pharmacies drugstore include pharmaceutical technical activities (procurement, receipt of goods, storage of goods, and sales) as well as non-technical activities of pharmacy drugstore (activity in the finance and administration department such as recording or daily administration in the form of daily report generation). Apothecary manager of Pharmacy drugstore (APA) have a role in determining policies of management in pharmacy drugstore, as well as carrying out the functions of supervision and control over all the components in the pharmacy drugstore, beside that, to carrying out its function as a apothecary to ensure the rational use of medicines.

Given a special task called analysis of hypertension treatment in the pharmacy drugstore in apotek kimia farma No. 50 Bogor. Special task aims to assess the treatment of hypertension and rational prescription so the pharmacist can know and understand the role of pharmacists in assessing prescribing rational treatment of hypertension. Based on the screening prescription in terms of aspects of administrative requirements, suitability pharmaceutical, and clinical judgment, generally prescription medication of hypertension is rational.
