Penelitian ini bertujuan untuk menguji pengaruh intellectual capital terhadap kinerja keuangan perusahaan, pertumbuhan perusahaan dan nilai pasar perusahaan. Dengan menggunakan model Pulic-Value Added Intellectual Coefficients (VAIC), penelitian ini menguji hubungan antara efisiensi value added (VAIC) dari tiga sumber daya utama perusahaan (aset fisik, human capital, dan structural capital) dengan kinerja keuangan perusahaan (ROE, NPM), pertumbuhan perusahaan (GR), dan nilai pasar perusahaan (MBV). Data yang digunakan adalah perusahaan padat Intellectual Capital, yaitu perusahaan sektor Automotive and Allied, Telekomunikasi, dan Real Estate and Property yang terdaftar di Bursa Efek Indonesia pada tahun 2008-2010. Hasil penelitian menunjukkan bahwa intellectual capital (VAIC) berpengaruh terhadap kinerja keuangan perusahaan (ROE, NPM), pertumbuhan perusahaan (GR), dan nilai pasar perusahaan(MBV). VACA berpengaruh signifikan positif terhadap Kinerja keuangan (ROE) dan nilai pasar perusahaan (MBV), sedangkan VAHU hanya berpengaruh terhadap kinerja keuangan (ROE,NPM)
