### Abstrak

In Sub-Department of Health , pharmacists play an important role to carry out the work of pharmacy in pharmacy service facilities . In addition to doing the work of pharmacy. Pharmacists can play a role in government as policy makers in the field of pharmacy , licensing, monitoring , and control of the means of pharmacy . Pharmacists also have many roles in the performance of duties and functions of the Sub-Department of Health . In Sub-Department of Health , Pharmacist role is more focused on the licensing process , training , supervision , and control of the means of pharmacy and pharmacy personnel . Pharmacists must have the knowledge , understanding and application of the licensing procedures and guidance , supervision and control of health care facilities and personnel , including pharmacy as human resources role in health care . In the implementation of the Sub-Department of Health PKPA in North Jakarta, prospective pharmacists should be able to figure out basic tasks and functions of the Sub-Department of Health North Jakarta , know the duties and functions of the Health Resources Section Coordinator particular section Pharmaceutical Food and Beverage (Farmakmin) and know the licensing, training, supervision , and control (binwasdal) against pharmaceutical health care facilities , food and beverage and pharmaceutical services to know and understand as well as the procurement of pharmaceuticals in the health center of Tanjung Priok, Koja and Kelapa Gading, Suku Dinas Kesehatan adalah Unit Kerja Dinas Kesehatan di kota administrasi.
