Abstrak

Rencana Strategis Kementerian Kesehatan periode 2010 - 2014 mengamanatkan Program Kefarmasian dan Alat Kesehatan untuk dapat meningkatkan ketersediaan, pemerataan, dan keterjangkauan obat dan alat kesehatan serta menjamin keamanan atau khasiat, kemanfaatan, dan mutu sediaan farmasi, alat kesehatan, dan makanan. Kementerian Kesehatan melalui Direktorat Jenderal Bina Kefarmasian dan Alat Kesehatan memiliki sasaran utama menjamin semua sediaan farmasi, makanan dan perbekalan kesehatan memenuhi syarat serta menjamin ketersediaan obat esensial dan alat kesehatan dasar di setiap daerah.
