Disertasi ini meneliti teks Al-Mawa>hib al-Mustarsalah ‘ala> at-Tuh}fah al-Mursalah. Ia merupakan komentar dari At-Tuh}fah al-Mursalah ila> Ru>h} an-Nabi> karya Muh}ammad b. Fad}lilla>h al-Burha>nfu>ri>. Empat pertanyaan penelitian yang diajukan: siapa pengarang teks Al-Mawa>hib al-Mustarsalah, bagaimana meneliti empat naskah yang diperoleh, apa isi teks, dan bagaimana kaitan isi teks dengan pemikiran tokoh sufi di dunia Islam dan di Nusantara. Penelitian ini bertujuan untuk menyajikan suntingan teks, terjemah, dan telaah syarh} wah}dat al-wuju>d yang terkandung di dalam teks. Penelitian ini merupakan penelitian filologi dengan menggunakan beberapa metode dan pendekatan seperti kodikologi, teori resepsi, pendekatan tematik dan historis, serta teori-teori dalam dunia tasawuf.
