

Hubungan tingkat pengetahuan dengan kesadaran perawat di Rumah Sakit Dr. Cipto Mangunkusumo perawat terhadap undang undang keperawatan = The relation between nurses of knowledge and awaresess toward the nursing act

Abstrak

Undang-Undang Keperawatan memberikan kewenangan bagi perawat untuk melakukan praktik secara mandiri di luar fasilitas pelayanan kesehatan. Dalam melaksanakan tugas sebagai pemberi pelayanan kesehatan perawat perlu bekerja sesuai dengan pengetahuan dan peraturan yang terdapat di dalam Undang-Undang Keperawatan. Minimnya pengetahuan dan kesadaran perawat terhadap Undang-Undang Keperawatan dapat mengakibatkan kondisi pasien tidak aman. Oleh karena itu dirasa penting untuk meneliti tingkat pengetahuan dan kesadaran perawat terhadap Undang-Undang Keperawatan. Penelitian ini menggunakan desain cross sectional pada 106 perawat dengan teknik cluster sampling. Instrumen penelitian berisi ketentuan umum, praktik keperawatan dan hak kewajiban perawat yang terdapat di dalam Undang-Undang Keperawatan. Penelitian ini menunjukkan bahwa tingkat pengetahuan dan kesadaran perawat terhadap Undang-Undang Keperawatan sudah baik (53.4%). Meskipun pengetahuan dan kesadaran yang dimiliki oleh perawat sudah baik, namun perawat harus tetap untuk lebih meningkatkan pengetahuan dan kesadaran tentang Undang-Undang Keperawatan secara keseluruhan.

Nursing Act delegated authority to nurses to conduct a practice outside the health care facility independently. In carrying out the duties as health providers, nurses had to work in accordance with the knowledge and rules contained in the regulation. Nurses' lack of knowledge and awareness of Nursing Act could lead to the endangering of patient's condition. Consequently, it becomes necessary to conducted a research on nurses' knowledge and awareness of the regulation. This research used a cross-sectional design on 106 nurses that were selected by using cluster-sampling technique. The research instruments were general provision, nursing practice, and the rights and responsibilities of nurses contained in Nursing Act. This research showed that actually nurses had already been aware of the regulation, and also had already understood it as well (53,4%). But despite already had sufficient knowledge and awareness, every nurse still had to increase their awareness and knowledge of Nursing Act wholly.
