Abstrak

[Kabupaten Lamongan saat ini berstatus sebagai Kawasan Ekonomi Khusus KEK kawasan kemaritiman industri perkapalan. Penunjukan tersebut didorong oleh faktor-faktor yang mendukung perkembangan industri galangan kapal di Kabupaten Lamongan. Skripsi ini akan berfokus kepada kebijakan pajak yang berlaku pada industri galangan kapal khususnya di Kabupaten Lamongan dan akan melakukan analisis apakah kebijakan pajak yang ada telah mendukung industri galangan kapal di Kabupaten Lamongan sesuai dengan perspektif Quintuple Helix. Penelitian ini dilakukan dengan pendekatan kualitatif dan metode kualitatif.
