## **Abstrak**

Konsep tersebut secara umum digunakan dalam media yang membahas politik internasional. Namun terdapat kecenderungan bahwa adanya kekurangan keseragaman dalam memahami hegemoni secara umum. Ulasan literatur ini memiliki sasaran untuk memperdalam inti dari konsep tersebut, yaitu terkait pembuatannya.
