Association of Southeast Asian Nations (ASEAN) yang identik sebagai asosiasi elit mulai melibatkan Civil Society Organizations (CSO) sebagai respon terhadap dinamika yang terjadi di level domestik, regional maupun internasional. Komitmen untuk menjadi lebih people-oriented ini dinyatakan dalam berbagai dokumen resmi ASEAN. Tugas Karya Akhir ini menyoroti mekanisme pelibatan CSO dalam proses regionalisme ASEAN dan kesesuaiannya dengan pernyataan-pernyataan formal yang tercantum pada dokumen resmi ASEAN.
