### Abstrak

Apoteker sebagai sumber daya manusia penyelenggara pelayanan kefarmasian di Rumah Sakit berperan penting dalam pelaksanaan Standar Pelayanan Kefarmasian di Rumah Sakit untuk mewujudkan pelayanan yang baik, aman, efektif, dan efisien kepada masyarakat. Terutama dalam era JKN dimana dana yang ada untuk melakukan pelayanan kefarmasian terbatas, peran apoteker menjadi sangat penting karena obat dan alat kesehatan merupakan komoditi kesehatan yang utama. Penggunaan obat dan perbekalan kefarmasian lainnya menjadi tanggung jawab apoteker yang melaksanakan pekerjaan kefarmasian di Rumah Sakit.

Praktek Kerja Profesi Apoteker dilaksanakan selama 2 bulan atau 38 hari kerja dari tanggal 1 September 2015 sampai dengan 30 Oktober 2015 di Rumah Sakit Kanker Dharmais Jl. Let. Jend. S. Parman Kav. 84-86, Slipi, Jakarta Barat.

Praktek kerja profesi dilaksanakan di Instalasi Farmasi, yaitu bagian satelit farmasi, gudang, produksi, depo farmasi rawat inap, dan farmasi klinik.

Kegiatan manajemen perbekalan farmasi yang dilakukan di apotek RSKD sesuai dengan Standar Pelayanan Kefarmasian di Rumah Sakit yaitu pemilihan, perencanaan, pengadaan, penerimaan, penyimpanan, pendistribusian, pemusnahan, pengendalian, pencatatan, dan pelaporan. Pelayanan farmasi klinik yang telah dilakukan di RSKD adalah pelayanan dan pengkajian resep,

rekonsiliasi obat, pelayanan informasi obat, konseling, visite, Pemantauan Terapi Obat (PTO), serta Monitoring Efek Samping Obat (MESO). Kegiatan produksi

yang dilakukan di RSKD meliputi produksi steril dan non-steril.

JKN especially in an era where the funds are separately perform limited pelayanan pharmacy, pharmacist rean becomes very important because drugs and medical devices is a major health commodities. The use of drugs and other pharmaceutical supplies are the responsibility of the pharmacist who carry out work at the hospital pharmacy.

Work Practice Pharmacists Profession held for 2 months or 38 working days of September 1, 2015 through to October 30, 2015 in Cancer Hospital Dharmais Jl. Let. Gen. S. Parman Kav. 84-86, Slipi, West Jakarta. Practice the profession undertaken in Pharmacy, which is part of a satellite pharmacy,

warehouse, production, pharmaceutical depot hospitalization, and clinical pharmacy.

Pharmaceuticals management activities conducted in accordance with Standards RSKD pharmacy Pharmaceutical Services at the Hospital, the choice, planning, procurement, receipt, storage, distribution, destruction, control, recording, and reporting. Clinical pharmacy services that have been performed in RSKD is dispensing and assessment prescription, medication reconciliation, drug information services, counseling, visite, Therapeutic Drug Monitoring (PTO), and Drug Side Effects Monitoring (meso). Production activities conducted in RSKD include production of sterile and non-sterile.
