## Abstrak

### <b>ABSTRAK</b><br>

Penelitian ini bertujuan untuk menganalisa dampak realisasi anggaran Atase Perdagangan terhadap ekspor non migas Indonesia di 24 negara dan di negara pasar tradisional yang terdapat Atase Perdagangan dari sisi nominal dan riil. Penelitian ini menggunakan metode estimasi dan regresi data panel realisasi anggaran total di 24 negara dan di negara pasar tradisional yang terdapat Atase Perdagangan secara nominal dan riil dari tahun 2011-2014. Hasil penelitian menemukan bahwa dampak realisasi anggaran Atase Perdagangan terhadap peningkatan ekspor non migas nominal tahun 2011-2014 paling signifikan terlihat pada realisasi anggaran nominal di negara pasar tradisional yang terdapat Atase Perdagangan dan ITPC (Indonesian Trade Promotion Center). Selain itu, Produk Domestik Bruto (PDB), nominal exchange rate, tariff, dan adanya Free Trade Area (FTA) juga signifikan berpengaruh terhadap ekspor non migas nominal di negara pasar tradisional yang terdapat Atase Perdagangan dan ITPC. Sedangkan dari sisi ekspor non migas riil, dampak realisasi anggaran Atase Perdagangan riil di 24 negara yang terdapat Atase Perdagangan paling signifikan meningkatkan volume ekspor non migas Indonesia. Sedangkan faktor lain yang signifikan meningkatkan ekspor non migas riil di 24 negara yang terdapat Atase Perdagangan yaitu PDB riil dan adanya FTA

### <b>ABSTRACT</b><br>

This study aims to analyze the impact of budget realization of The Trade Attache on Indonesian non-oil exports in 24 countries and in countries that are traditional markets Trade Attache of the nominal and real terms. This study uses panel data regression estimation and realization of the budget total in 24 countries and in countries that are traditional markets Trade Attache in nominal and real terms from 2011-2014. The study found that the impact of budget realization Trade Attache of the nominal increase in non-oil exports in 2011-2014 most significantly to the realization of the state budget in the face of traditional markets which are the Trade Attaché and ITPC (Indonesian Trade Promotion Center). In addition, the Gross Domestic Product (GDP), the nominal exchange rate, tariff, and the Free Trade Area (FTA) also significantly effect the nominal non-oil exports in the traditional market countries contained Trade Attaché and ITPC. In terms of non-oil exports of the real impact of the budget realization of real Trade Attache in 24 countries which are the most significant increase the volume of non-oil exports Indonesia. Meanwhile, another factor that significantly increases the real non-oil exports in the 24 countries which are the Trade Attaché namely real GDP and the FTA.
