ABSTRAK

Praktek Kerja Profesi (PKP) yang dilaksanakan di Apotek Kimia Farma No. 345 Tebet berlangsung selama satu bulan. Kegiatan ini bertujuan agar mahasiswa mampu memahami tugas dan tanggung jawab Apoteker dalam pengelolaan Apotek, serta melakukan praktek Pelayanan Kefarmasian sesuai dengan Peraturan Kementerian Kesehatan (RI) Nomor 35 Tahun 2014 tentang Standar Pelayanan Kefarmasian di Apotek; memiliki wawasan, pengetahuan, keterampilan, dan pelayanan praktis untuk melakukan praktek kefarmasian; dan memiliki gambaran nyata tentang permasalahan praktek kefarmasian serta mempelajari strategi dan kegiatan-kegiatan yang dapat dilakukan dalam rangka pengembangan praktek kefarmasian. Kegiatan pengelolaan dan pelayanan kefarmasian di Apotek Kimia Farma No. 345 telah berjalan dengan baik. Tanggung jawab Apoteker dalam pengelolaan Apotek adalah melakukan fungsi manajerial, yaitu perencanaan, pengadaan, penerimaan, penyimpanan, pemusnahan, pengendalian, pencatatan, dan pelaporan, serta melakukan pelayanan farmasi klinik yang terdiri dari dari pengkajian resep, dispensing, konseling, pemberian informasi obat, pelayanan kefarmasian di rumah, PTO, dan MESO. Pelaksanaan kegiatan PKPA di Apotek Kimia Farma No. 345 sudah cukup memberikan wawasan, pengetahuan, keterampilan, dan pelayanan praktis untuk melakukan Praktek Kefarmasian. Permasalahan Praktek Kefarmasian yang didapat selama PKPA adalah menjawab kebutuhan pasien mengenai obat yang tersedia di Apotek dan pendisiplinan Tenaga Kefarmasian mengenai pengelolaan Sediaan Farmasi, Alat Kesehatan, dan Bahan Medis Habis Pakai.

ABSTRAK

Profession Internship was held in Apotek Kimia Farma No. 345 Tebet for a month. This internship aims for the students to understand the duties and responsibilities of pharmacists in the management of Apotek, as well as pharmaceutical care practices based on Health Ministry Regulations Number 35 of 2014 about Pharmaceutical Care Standard in Apotek; have the insights, knowledges, skills, and practical experiences to practice pharmacy; and have a real image about the problems of pharmaceutical practices, learn the strategies and activities that can be done in order to develop the pharmaceutical practice. Management and pharmaceutical care in Apotek Kimia Farma No. 345 have been done well. The responsibility of pharmacists in management pharmacy were performing managerial functions including planning, procurement, receipt, storage, destruction, control, recording, and reporting, and also the service of clinical pharmacy including prescribing assessment, dispensing, counseling, provision of drug information, home care, PTO, and MESO. Profession Internship in Apotek Kimia Farma No. 345 has gained the insights, knowledge, skills, and practical service for being implemented in pharmaceutical practice. Pharmaceutical practice problems obtained during PKPA was answering the needs of patients on the drugs availability in Apotek and pharmaceutical workers discipline on the management of Pharmaceutical Products, Medical Devices,
