### Abstrak

#### <b>ABSTRAK</b><br>

Penelitian skripsi ini membahas mengenai dinamika pengawasan pelaksanaan penanaman modal asing sektor kehutanan di Kalimantan Timur 1967-1973. Proses tahapan pelaksanaan Penanaman Modal Asing di sektor Kehutanan melibatkan berbagai unsur pemerintahan, baik pusat maupun daerah. Dibutuhkan kesepakatan di antara unsur pemerintah yang berkaitan agar tidak terjadi kesimpangsiuran. Kejelasan alur pelaksanaan penanaman modal asing memengaruhi penilaian calon penawar dan ketertiban secara umum. Oleh karena itu, perlu sinkronisasi di antara badan-badan pemerintahan dalam menyusun program dan kebijakan Penanaman Modal Asing yang terpadu. Upaya-upaya yang dilakukan pemerintah adalah dengan membentuk Badan Pertimbangan Penanaman Modal Asing yang dibantu oleh Team Teknis Penanaman Modal Asing, Sektor R Team Khusus Pengawasan Modal Asing dan Team Pengawasan Penanaman Modal Asing bidang Kehutanan. Keempat badan tersebut bertanggung jawab terhadap kelancaran penanaman modal asing secara administratif dan implementatif. Secara garis besar penelitian ini membahas mengenai proses koordinasi yang sinergis menuju satu sistem terpadu dalam memberikan pelayanan dan pemantauan terhadap pelaksanaan penanaman modal asing sektor Kehutanan khususnya di Kalimantan Timur.

#### <b>ABSTRACT</b><br>

This research discuss the dynamics of foreign investment monitoring implementation in East Kalimantan 39 s forestry sector 1967 1973. Phase of foreign investment process in forestry sector involves various members of government, both central and local. It requires agreement between interrelated government elements to avoid confusion. Clarity of its implementation worklfow affect the assessment prospective bidders and order in general. Therefore, it is necessary to synchronize between government bodies in formulating integrated programs and policies. The efforts made by government is the established of Foreign Investment Advisory Board, assisted by the Foreign Investment Technical Team, Sector R Special Team of Foreign Assets Control and the Foreign Investment Monitoring Team in Forestry. The fourth body responsible for foreign investment order administratively and implementation. Broadly speaking, this study discusses the synergistic coordination process towards an integrated system in providing services and monitoring of foreign investment implementation in East Kalimantan 39 s forestry sector 1967 1973.
