

Strategi kepemimpinan penanggulangan terorisme di Indonesia: studi kasus kepemimpinan Muhammad Tito Karnavian = Strategy leadership in combating terrorism Indonesia: Muhammad Tito Karnavian leadership case study

Abstrak

Penyebaran paham radikalisme dan aksi terorisme merupakan permasalahan serius yang mengancam kesatuan dan persatuan Negara Republik Indonesia. Terorisme yang berkembang di Indonesia ternyata tidak hanya melingkupi wilayah kedaulatan Indonesia saja, namun operasionalnya hingga ke wilayah Asia Tenggara bahkan dunia Internasional. Penelitian ini menggunakan pendekatan kualitatif dan pemilihan narasumber dengan teknik purposive sampling. Lokasi penelitian di Polda Metro Jaya, Densus 88 AT Mabes Polri dan Badan Nasional Penanggulangan Terorisme.

Hasil penelitian menunjukkan bahwa pertama, law enforcement-led strategy lebih cocok digunakan di Indonesia, karena pasca reformasi urgensi terhadap HAM lebih dikedepankan dan law enforcement-led strategy lebih sesuai dengan sistem demokrasi Indonesia saat ini. Kedua, Strategi Pengambilan keputusan Muhammad Tito Karnavian selalu didasarkan pada fakta yang terjadi dilapangan dan pertimbangan manajerial perkara, dengan diperkuat informasi dari intelijen. Ketiga, dalam penyelesaian konflik Muhammad Tito Karnavian melakukan pendekatan-pendekatan kepada pihak yang berkonflik untuk mengetahui akar permasalahannya konflik dengan mendatangi satu persatu pihak-pihak yang berkonflik.

.....The spread of radicalism and terrorism is a serious problem that threatens the unity and integrity of the Republic of Indonesia. Growing terrorism in Indonesia covers not only the sovereign territory of Indonesia, but its operations to Southeast Asia and even the world. This study uses a qualitative approach and the selected informants by using purposive sampling technique. This research is located in Polda Metro Jaya, Densus 88 AT Police and the National Agency for Combating Terrorism.

The results shows that first the law enforcement led strategy is more suitable for using in Indonesia, because in the post reform the urgency of human rights has been put forward and law enforcement led strategy is more in line with Indonesia 39 s democratic system. Second, decision making strategies of Muhammad Tito Karnavian are always based on facts that occur in the field and considerations of managerial matters, with strengthened informations from agent provocateur. Third, in solving the conflicts Muhammad Tito Karnavian approaches to the conflicting parties to find out the root of the problem conflict by visiting one another.
