Abstrak

ABSTRAK

Praktek kerja profesi apoteker di Rumah Sakit Kanker Dharmais dilaksanakan selama 8 minggu, yaitu sejak tanggal 11 Juli sampai dengan 1 September 2016. Tujuan dilaksanakannya praktek kerja agar mahasiswa mampu memahami peranan, tugas, dan tanggung jawab apoteker di Rumah Sakit sesuai dengan standar dan etika pelayanan kefarmasian. Instalasi Farmasi Rumah Sakit Kanker Dharmais sudah melaksanakan kegiatan praktik kefarmasian secara komprehensif dan berkesinambungan sesuai dengan Peraturan Menteri Kesehatan No. 58 tahun 2014 tentang Standar Pelayanan Kefarmasian di Rumah Sakit. Praktik kefarmasian yang ada di Instalasi Farmasi Rumah Sakit Kanker Dharmais yang meliputi manajemen farmasi dan pelayanan farmasi klinik. Kegiatan manajemen di RSKD telah dijalankan dan diterapkan dengan baik sedangkan kegiatan pelayanan farmasi klinis di RSKD belum semuanya dilaksanakan. Penerapan farmasi klinis di RSKD meliputi pengkajian resep, rekonsiliasi obat, pelayanan informasi obat, visite, konseling, pemantauan terapi obat, evaluasi penggunaan obat, monitoring efek samping obat, dan dispensing atau produksi sediaan steril. Kegiatan produksi yang dilakukan Instalasi Farmasi Rumah Sakit Kanker Dharmais terdiri dari kegiatan produksi non steril dan kegiatan produksi steril yang meliputi pelayanan pencampuran sediaan intravena dan penanganan obat sitostatika, yang sudah dilaksanakan dengan baik.

ABSTRACT

Internship at Dharmais Cancer Hospital carried out for 8 weeks, since July, 11st, until September, 1st, 2016. This internship was intended to make apothecary student understand the role, duties, and responsibilities of pharmacist at hospital in accordance with standard and ethic of pharmaceutical care. Pharmacy Intallation of Dharmais Cancer Hospital has been carried out pharmaceutical practice in a comprehensive and sustainable in accordance with Minister of Health rsquo s Regulation Number 58 of 2014 about Standards of Pharmaceutical Care at the Hospital. Pharmacy practice in pharmacy installation at Dharmais Cancer Hospital includes management of pharmacy and clinical pharmacy services. Management of pharmacy at Dharmais Cancer Hospital been implemented well while the clinical pharmacy service is not all implemented. Application of clinical pharmacy at RSKD include prescription, medication reconciliation, drug information services, visite, counseling, monitoring drug therapy, evaluation of drug use, monitoring of drug side effects, and dispensing or production of sterile preparations. Pharmacy Installation of Dharmais Cancer Hospital undertaken for non sterile production and sterile production which include preparation of intravenous admixture and handling cytotoxic. The production already implemented well.
