Praktek Kerja Profesi di Rumah Sakit Anak dan Bunda Harapan Kita dilakukan selama 6 minggu yang dimulai pada 18 Juli 2016 hingga 27 Agustus 2016. Praktek kerja profesi ini bertujuan untuk membuat mahasiswa calon Apoteker memahami peran dan tanggung jawab dari Apoteker di rumah sakit berdasarkan Peraturan Menteri Kesehatan No. 58 tentang Standar Pelayanan Kefarmasian di Rumah Sakit. Pada peraturan tersebut, Apoteker di rumah sakit bertanggung jawab dalam kegiatan pengelolaan sediaan farmasi, alat kesehatan, dan bahan medis habis pakai dan kegiatan pelayanan farmasi klinik.
