### Abstrak

Praktek Kerja Profesi di Apotek Kimia Farma No. 143 dilakukan selama 4 minggu yang dimulai pada 5 September 2016 hingga 31 September 2016. Praktek kerja profesi ini bertujuan untuk membuat mahasiswa calon Apoteker memahami peran dan tanggung jawab dari Apoteker di Apotek berdasarkan Peraturan Menteri Kesehatan No. 35 tentang Standar Pelayanan Kefarmasian di Apotek. Pada peraturan tersebut, Apoteker di Apotek bertanggung jawab dalam kegiatan pengelolaan sediaan farmasi, alat kesehatan, dan bahan medis habis pakai dan kegiatan pelayanan farmasi klinik. Hasil pengamatan selama melakukan praktek kerja profesi di Apotek Kimia Farma No. 143 menunjukkan bahwa Apoteker di Apotek bertanggung jawab secara penuh dalam praktek pelayanan kefarmasian yang meliputi pengelolaan sediaan farmasi, alat kesehatan, dan bahan medis habis dan pelayanan farmasi klinik. Kegiatan pengelolaan sediaan farmasi, alat kesehatan, dan bahan medis habis pakai di Apotek Kimia Farma No. 143 sudah sepenuhnya dilakukan berdasarkan peraturan Menteri Kesehatan No.35 dan untuk kegiatan farmasi klinik yang sudah dilakukan adalah pelayanan resep, dispensing, pemberian informasi obat, konseling, pelayanan kefarmasian di rumah, dan pemantauan terapi obat Telefarma.

.....The Profession internship was intended to make pharmacists student understand the role and responsibilities of pharmacists in pharmacy based on the Minister of Health No. 35 about Standards of Pharmaceutical Services at the Pharmacy. In these regulations, Pharmacists in a pharmacy is responsible for the management of pharmaceutical, medical devices, and other medical consumables tools and clinical pharmacy service. Observations result during Profession internship at Kimia Farma Pharmacy showed that pharmacists in the Pharmacy takes full responsibility in the practice of pharmacy services that include management of pharmaceutical, medical devices, and other medical consumables tools and clinical pharmacy services. Management activities of pharmaceutical, medical devices, and other medical consumables tools in Kimia Farma Pharmacy has been fully carried out under laws Health Minister No. 35 and the clinical pharmacy services that have been carried out were prescription services, dispensing, provision of drug information, konseling, home pharmacy care, and monitoring drug therapy Telefarma.
