Indonesia dalam mengamankan penerimaan kargo udara sudah memiliki upaya yang baik untuk mencegah berbagai kejahatan melalui kargo udara termasuk penyelundupan narkoba transnasional. Namun, berdasarkan kasus yang terjadi pada tahun 2016 serta data tegahan penyelundupan narkotika melalui kargo udara oleh Bea Cukai menunjukkan bahwa pengamanan penerimaan kargo udara Indonesia memerlukan optimalisasi. Uni Eropa sudah memperkuat pengamanan penerimaan kargo-nya setelah ditemukan sebuah bom rakitan dalam pesawat kargo dari Yaman. Pengamanan Uni Eropa menggunakan sistem validasi yang disebut sebagai Air Cargo and Mail Carrier operating into the EU from a Third Country Airport atau ACC3, dimana negara diluar Uni Eropa diwajibkan memiliki validasi dari Uni Eropa untuk mengirim kargo udara menuju Uni Eropa. Berdasarkan pencegahan kejahatan situasional, penulis membahas tentang potensi diterapkannya sistem validasi penerimaan kargo udara berdasarkan ACC3 sebagai upaya preventif penyelundupan narkoba transnasional di Indonesia. Pada artikel ini, pencegahan kejahatan situasional dikaitkan pada tingkat public policy dimana strategi pencegahan memiliki bentuk suatu kebijakan pemerintah sebagai upaya pengamanan suatu negara.

In securing air cargo, Indonesia already have a good efforts to prevent crimes through air cargo including transnational drug smuggling. However, based on the case that occurred in 2016 as well as restraining drug trafficking via air cargo data by Customs showed that the air cargo security reception Indonesia requires optimization. The European Union has reinforce its cargo security reception after they were discovered an IED in the cargo aircraft from Yemen. EU security using the validation system referred to as Air Cargo and Mail Carrier operating into the EU from a Third Country Airport or ACC3, where countries outside the European Union are required to have validation from the European Union to send air cargo towards the European Union. Based on situational crime prevention, the author discusses the potential application of air cargo validation system based on ACC3 as a preventative measure of transnational drug smuggling in Indonesia. In this journal, refer to situational crime prevention on the level of public policy where prevention strategies have the form of a government policy as an effort to secure a country.
