Apotek merupakan tempat dilakukannya praktik kefarmasian oleh Apoteker yang menjadi salah satu sarana pelayanan kesehatan dalam membantu mewujudkan tercapainya derajat kesehatan yang optimal bagi masyarakat. Apotek juga sebagai salah satu tempat pengabdian dan praktik profesi apoteker dalam melakukan pekerjaan kefarmasian, serta merupakan suatu tempat bisnis, sehingga apoteker juga dituntut untuk memiliki keahlian dalam hal manajerial dan kemampuan dalam mengembangkan bisnis. Pelayanan kefarmasian di Apotek meliputi pengelolaam sediaan farmasi, alat kesehatan dan bahan medis habis pakai serta pelayanan farmasi klinik. Pengelolaan sediaan farmasi, alat kesehatan dan bahan medis habis pakai terdiri dari perencanaan, pengadaan, penerimaan, penyimpanan, pemusnahan, pengendalian, pencatatan dan pelaporan. Pelayanan farmasi klinik meliputi pengkajian resep, dispensing, pelayanan informasi obat PIO , konseling, pelayanan kefarmasian di rumah home pharmacy care , pemantauan terapi obat PTO , dan monitoring efek samping obat MESO . Pelayanan kefarmasian di Apotek Kimia Farma no. 202 Depok sudah berjalan secara optimal, namun pelayanan farmasi klinik berupa konseling, home pharmacy care, PTO dan MESO belum dilakukan secara rutin.

**ABSTRACT

Pharmacy is where the practice of pharmacy by pharmacists who became one means of health services in helping realize the optimal health status for the community. Pharmacy are also one of the places of dedication and practice of the pharmacist profession in doing pharmaceutical work, and a place of business, so the pharmacist is also required to have managerial skills and ability in developing the business.

Pharmaceutical care in Pharmacy include pharmaceutical management, medical equipment and medical consumables and clinical pharmacy services. Management of pharmaceutical preparations, medical devices and medical consumables consists of planning, procurement, receipt, storage, destruction, controlling, recording and reporting. Clinical pharmacy services include prescription assessment, dispensing, drug information service PIO , counseling, home pharmacy care, monitoring drug therapy PTO , and monitoring of drug side effects MESO . Pharmaceutical care in Kimia Farma Pharmacy no. 202 Depok has been running optimally, but the clinical pharmacy services in the form of counseling, home pharmacy care, PTO and MESO has not been done routinely.
