Kegiatan pelayanan farmasi klinis yang sudah dilakukan Apotek Kimia Farma No. 352 diantaranya pengkajian dan pelayanan resep, dispensing, pelayanan informasi obat, konseling, pelayanan kefarmasian di rumah, pemantauan terapi obat dan monitoring efek samping obat.
