## Abstrak

### <b>ABSTRAK</b><br>

Pelayanan kefarmasian saat ini telah mengalami perubahan yang semula hanya berfokus kepada pengelolaan obat drug oriented berkembang menjadi pelayanan komprehensif. Berdasarkan hal tersebut maka seorang Apoteker di apotek dituntut untuk memiliki kompetensi dalam mengelola sebuah apotek baik dari segi manajerial maupun seluruh pelayanan kefarmasian yang ada di dalamnya. Mengingat pentingnya peran Apoteker tersebut, kegiatan Praktik Kerja Profesi Apoteker PKPA di sebuah apotek dilaksanakan. Kegiatan PKPA ini bertujuan agar mahasiswa calon apoteker mendapatkan gambaran umum mengenai kegiatan rutin Apoteker di apotek serta memahami peran dan tugas Apoteker dalam pengelolaan apotek dan dalam hal pelayanan kefarmasian sesuai dengan peraturan dan etika yang berlaku. Kegiatan PKPA ini dilaksanakan di Apotek Hidup Baru yang berlangsung dari tanggal 1 Maret - 31 Maret 2017. Berdasarkan PKPA yang telah dilakukan, Kegiatan rutin yang dilakukan di Apotek Hidup Baru meliputi kegiatan teknis kefarmasian dan kegiatan non teknis kefarmasian yang seluruh pelaksanaannya membutuhkan peran dari seorang Apoteker. Peran dan tugas Apoteker di apotek berdasarkan standar pelayanan kefarmasian di apotek dapat bersifat manajerial dan farmasi klinik yang secara keseluruhan sudah diterapkan di Apotek Hidup Baru kecuali kegiatan Home Pharmacy Care, Pemantauan Terapi Obat PTO , dan Monitoring Efek Samping Obat MESO .

### <b>ABSTRACT</b><br>

The current pharmaceutical service has undergone changes that were originally composed only for the management of developing drugs drug oriented into comprehensive services. Based on that, a pharmacist at a pharmacy is required to have competence in managing a pharmacy, in managerial terms and all pharmaceutical services. The importance of the Pharmacist 39 s role, internship at a pharmacy is implemented. This activities are aimed at getting prospective pharmacist students to get an overview of routine pharmacist activities at pharmacies as well as understanding the role and duties of pharmacists in pharmacy management and in pharmaceutical services in accordance with applicable rules and ethics. Internship is held at Hidup Baru Pharmacy from March 1 to March 31, 2017. Based on internship that has been done, routine activities carried out at Hidup Baru Pharmacy include pharmaceutical technical activities and non technical pharmaceutical activities that all of its implementation requires the role of a Pharmacist. The role and duties of pharmacists in pharmacies based on pharmacy service standards in pharmacies may be managerial and clinical pharmacies as a whole already implemented in Hidup Baru Pharmacy except for home pharmacy care, therapeutic drug monitoring, and side effects of drugs monitoring.
