Industri farmasi wajib menerapkan Cara Pembuatan Obat yang Baik CPOB dalam melakukan rangkaian proses pembuatan obat yang bertujuan untuk memastikan bahwa mutu obat yang dihasilkan akan konsisten, memenuhi persyaratan yang ditetapkan, dan sesuai dengan tujuan penggunaannya. Praktek Kerja Profesi Apoteker PKPA dilaksanakan di PT.
