### Abstrak

#### <b>ABSTRAK</b>

Suku Dinas Kesehatan merupakan unit kerja Dinas Kesehatan pada masing-masing Kota Administrasi di wilayah DKI Jakarta yang bertugas melaksanakan kegiatan pembinaan, pengawasan, pengendalian, dan pengembangan kesehatan masyarakat serta kesehatan perseorangan. Seksi Sumber Daya Kesehatan SDK merupakan salah satu Seksi di Suku Dinas Kesehatan yang bertanggung jawab dalam pelaksanaan kegiatan pembinaan dan pengawasan di bidang kefarmasian dan sumber daya kesehatan lainnya. Bagian ini merupakan tempat bagi Apoteker dalam menjalankan peran dan tugasnya pada lingkup Pemerintahan. Praktek Kerja Profesi Apoteker PKPA dilaksanakan di Suku Dinas Kesehatan Kota Administrasi Jakarta Barat pada tanggal 4 Januari hingga 24 Januari 2017, khususnya di Seksi Sumber Daya Kesehatan SDK. Pelaksanaan PKPA bertujuan untuk memahami tugas dan tanggung jawab Apoteker di Suku Dinas Kesehatan, memahami tugas pokok dan fungsi Suku Dinas Kesehatan, memiliki wawasan dan pengalaman praktis dalam melakukan pekerjaan di pemerintahan, dan memiliki gambaran nyata tentang permasalahan kefarmasian di pemerintahan. Kegiatan yang dilakukan selama PKPA di Suku Dinas Kesehatan Kota Administrasi Jakarta Barat antara lain binwasdal Apotek Rakyat, sosialisasi Peraturan Menteri Kesehatan terkait pengaturan Apotek Rakyat, membantu pengelolaan persediaan obat dan perbekalan kesehatan di Gudang Suku Dinas Kesehatan Jakarta Barat, serta melakukan rekapitulasi dan analisis pelaporan narkotika dan psikotropika tahun 2016.

#### <i><b>ABSTRACT</b></i>

Regional Health Department is the work unit of the Health Department in each administrative city in DKI Jakarta which is responsible for carrying out the activities of guiding, supervising, controlling, and developing the public health and personal health. The Health Resources Section is one of the sections in Regional Health Department which is responsible for carrying out the supervision and guidance activities in the field of pharmaceutical and other health resources. This section is a place for pharmacists to do their roles and duties in the scope of government. Internship at Regional Health Department of West Jakarta was held on January 4th to January 24th 2017, especially in the Health Resources Section. This internship aims to understand the duties and responsibilities of pharmacist in Regional Health Department, understand the main tasks and functions of Regional Health Department, obtain the knowledge and practical experiences to do the work in government, and obtain a real description of pharmaceutical issues in government. The activities that conducted during internship at Regional Health Department of West Jakarta were doing supervision, guidance, and control of Apotek Rakyat, socialization of the regulation related to Apotek Rakyat, assisting the management of pharmaceutical products and health supplies at the warehouse of Regional Health Department of West Jakarta, and doing recapitulation and analysis of narcotic and psychotropic reports in 2016.</i>
