Abstrak

Apotek adalah sarana pelayanan kefarmasian tempat dilakukan praktik kefarmasian oleh apoteker. Pelayanan kefarmasian merupakan suatu pelayanan langsung dan bertanggung jawab kepada pasien yang berkaitan dengan sediaan farmasi dengan maksud mencapai hasil yang pasti untuk meningkatkan mutu kehidupan pasien. Praktik Kerja Profesi Apoteker PKPA di Apotek Kimia Farma No. 115 dilaksanakan pada bulan April 2017 dengan tujuan agar mahasiswa apoteker lebih memahami tugas, peran dan tanggung jawab apoteker di apotek yang berdasarkan pada standar pelayanan kefarmasian, baik secara teknis maupun non teknis kefarmasian. Kegiatan pengelolaan sediaan farmasi, alat kesehatan dan bahan medis habis pakai di Apotek Kimia Farma No. 115 telah sesuai dengan Peraturan Menteri Kesehatan Republik Indonesia No. 73 Tahun 2016 tentang Standar Pelayanan Kefarmasian di Apotek. Pelayanan farmasi klinik di Apotek Kimia Farma No. 115 yang belum dilaksanakan secara optimal adalah konseling, home pharmacy care, dan pemantauan terapi obat sedangkan monitoring efek samping obat belum dilaksanakan.

Pharmacy is a pharmaceutical care facility where pharmaceutical practices are done by apothecary. Pharmaceutical care is a direct care and responsible to the patient associated with pharmaceutical preparations with the intention of reaching a definitive result to improve the quality of life of patients. Profession Internship at Kimia Farma Pharmacy No. 115 was held at April 2017 with the intention that apothecary students understand the tasks, roles and responsibilities of apothecary in pharmacies based on standards of pharmaceutical care, both technically and non technically. Managerial activities of pharmaceutical preparations, medical devices and medical consumables in Kimia Farma Pharmacy No. 115 have been in accordance with the Regulation of Minister of Health of the Republic of Indonesia No. 73 Year 2016 about Standarization of Pharmaceutical Care in Pharmacy. Clinical pharmacy activities in Kimia Farma Pharmacy No. 115 that have not been implemented optimally are counseling, home pharmacy care and monitoring of drug therapy while monitoring of drug side effects has not been implemented.
