ABSTRAK

Laporan ini menjelaskan tentang praktik kerja profesi yang dilakukan oleh mahasiswa apoteker di Apotek Kimia Farma Nomor 352 Depok. Tujuan dilakukannya praktik kerja profesi adalah agar mahasiswa apoteker mampu memahami tugas dan tanggung jawab apoteker dalam pengelolaan apotek, serta melakukan praktik pelayanan kefarmasian sesuai dengan ketentuan perundang-undangan dan etika yang berlaku, memiliki wawasan, pengetahuan, keterampilan, dan pengalaman praktis untuk melakukan praktik kefarmasian di apotek serta memiliki gambaran nyata tentang permasalahan praktik kefarmasian dan mempelajari strategi dan kegiatan-kegiatan yang dapat dilakukan dalam rangka pengembangan praktik kefarmasian. Praktik kerja profesi ini dilaksanakan selama satu bulan. Tugas khusus yang diberikan selama praktik kerja profesi adalah "Pengkajian Resep Penyakit Kardiovaskular di Apotek Kimia Farma Nomor 352 Depok Periode Bulan Januari 2018". Penulisan laporan ini dilakukan berdasarkan pengamatan langsung dan dilihat kesesuaiannya dengan peraturan perundang-undangan. Hasil dari praktik kerja ini diantaranya mengenai tanggung jawab apoteker di bidang manajerial dan farmasi klinik dan apotek sudah beroperasi sesuai dengan ketentuan.

This report describes the internship experience which was done by an apothecary student at Kimia Farma 352 Depok Pharmacy. The purpose of this internship were to understand the duties and responsibilities of pharmacists in pharmacy management, as well as to practice pharmaceutical services in accordance with applicable legislation and ethics, have insight, knowledge, skills and practical experience to perform pharmaceutical practices at the pharmacy as well as having a clear picture of the pharmaceutical practice issues and studying the strategies and activities that can be undertaken in order to develop pharmaceutical practices. This internship was conducted for a month. The special assignment given during the internship was called Assessment of Cardiovascular Disease Prescription at Kimia Farma 52 Depok Pharmacy Period January 2018 . The writing of this report was based on direct observation to verify the conformity towards the valid regulation. The conclusion were that the pharmacy has always been complied with the provisions and pharmacists are responsible in both managerial and pharmacy clinic.
