## Abstrak

### <b>ABSTRAK</b>

Laporan ini menjelaskan tentang praktik kerja profesi yang dilakukan oleh mahasiswa apoteker di Suku Dinas Kesehatan Kota Administrasi Jakarta Timur. Tujuan dilakukannya praktik kerja profesi adalah agar calon apoteker mampu memahami peranan, tugas, dan tanggung jawab apoteker di instansi pemerintahan seperti Suku Dinas Kesehatan, memiliki pengetahuan tentang tupoksi instansi-instansi pemerintahan di bidang farmasi, memiliki wawasan, pengetahuan, keterampilan, dan pengalaman praktis melakukan pekerjaan di pemerintahan serta memiliki gambaran nyata tentang permasalahan kefarmasian di pemerintahan..
