

Praktik kerja profesi di suku dinas kesehatan kota administrasi jakarta timur periode januari tahun 2018 = Study apprenticeship in east jakarta sub department for health january 2018 period

Abstrak

Praktek kerja profesi PKPA di Suku Dinas Kesehatan Kota Administrasi Jakarta Timur periode Januari tahun 2018 bertujuan untuk mengetahui tugas dan tanggung jawab Apoteker di Instansi Pemerintahan, memiliki pengetahuan terkait tugas pokok dan fungsi Suku Dinas Kesehatan di bidang farmasi, memiliki wawasan, pengetahuan, keterampilan, dan pengalaman praktis melakukan pekerjaan kefarmasian di Suku Dinas Kesehatan, serta mendapatkan gambaran nyata tentang permasalahan kefarmasian di Suku Dinas Kesehatan. Selama menjalani PKPA, penulis ditempatkan di Puskemas Kecamatan Jatinegara untuk merekap dan membuat laporan rata-rata penggunaan obat generik; data pelayanan kefarmasian meliputi kunjungan resep per tahun, tenaga kefarmasian, dan layanan farmasi klinik; serta ketersediaan obat dan vaksin esensial selama setahun. Secara umum, persentase penggunaan obat generik yang didapatkan sebesar 87,23 , beban kerja Apoteker didapati tidak seimbang dilihat dari total resep, serta disimpulkan bahwa Puskesmas Kecamatan Jatinegara memiliki stok yang hampir lengkap selama setahun untuk 20 jenis obat indikator. Di sisi lain, penulis telah mendapatkan pengetahuan, pengalaman dan wawasan yang cukup dalam melakukan pekerjaan kefarmasian, khususnya di Puskesmas dan Suku Dinas Kesehatan.<hr />Study Apprenticeship PKPA in East Jakarta Sub Department for Health January 2018 period aims to understand the duties and responsibilities of Pharmacists in Goverment Agencies, know the main duties and functions of Sub Department for Health related to Pharmacy, get insights, knowledge, skills and field experience to undertake pharmaceutical practice in Sub Department for Health, have a real experience related to challenges in pharmaceutical practices in Sub Department for Health. While doing the apprenticeship, author was placed in Jatinegara Communiy Health Center to compile and write a report about the use of generic drugs; pharmaceutical practices data, namely total prescriptions per year, working Pharmacists, and clinical practices in a year period; and essential drugs and vaccines availability within a year. In general, the use of generic drugs in Jatinegara Communiy Health Center was 87,23 , pharmacists rsquo; responsibilities was found higher than required considering the total income of prescriptions, and 20 indicator drugs was seen to be in a complete stock for almost a year round full. In addition, author has also gained enough knowledge as well as experience in doing pharmaceutical practices, especially in Communiy Health Center and Sub Department for Health.
