### Abstrak

Suku Dinas Kota merupakan unit kerja Dinas Kesehatan pada Kota/Kabupaten Administrasi di Provinsi Daerah Khusus Ibukota yang bertugas melaksanakan kegiatan pembinaan dan pengembangan kesehatan masyarakat khususnya di wilayah Jakarta Timur. Praktek Kerja Profesi PKP di Suku Dinas Kesehatan Jakarta Timur dilakukan pada tanggal 19 Maret ndash; 2 April 2018. Tujuan pelaksanaan PKP untuk mendapatkan pengalaman, pengetahuan, gambaran, dan pemahaman yang lebih mendalam tentang peran, tugas, dan tanggung jawab Apoteker di lingkup pemerintahan. Kegiatan yang dilakukan selama PKP antara lain merekapitulasi kegiatan pembinaan, pengawasan, dan pengendalian Binwasdal sarana farmasi seperti RSUD dan Puskesmas Kecamatan di Jakarta Timur. Apoteker di Suku Dinas Kesehatan Jakarta Selatan memiliki peranan yang penting dalam melakukan tugasnya yaitu pembinaan, pengawasan, dan pengendalian sarana farmasi, makanan, dan minuman; pengelolaan obat program, vaksin, dan obat buffer; pengelolaan pelaporan seperti LPLPO, POR, SIPNAP; serta kegiatan pendampingan.

East Jakarta Sub Department for Health is a work unit of Health Office at City/District Administration in Province of Special Capital Region Jakarta which is tasked to carry out development activity of public health especially in East Jakarta area. Internship at East Jakarta Sub-Department For Health was held on March 19th - April 2nd, 2018. The purpose of internship implementation was to gain experience, knowledge, description, and understanding the role, duties and responsibilities of Pharmacists in the government. Activities undertaken during internship include recapitulation of guidance, supervision and control activities Binwasdal of pharmaceutical facilities such as RSUD and Puskesmas Kecamatan in East Jakarta. Pharmacists in South Jakarta Sub Department for Health have an important role in performing their duties, such as guidance, supervision and control activities of pharmaceutical, food and beverage facilities; drug management programs, vaccines, and buffer drugs; reporting management such as LPLPO, POR, SIPNAP; and assistance activities.
