## Abstrak

Praktik Kerja Profesi di Suku Dinas Kesehatan Kota Administrasi Jakarta Timur Bulan Mei Tahun 2018 bertujuan untuk memahami peranan, tugas, dan tanggung jawab apoteker di Suku Dinas Kesehatan, memiliki wawasan, pengetahuan, keterampilan, dan pengalaman praktis, serta memiliki gambaran nyata tentang permasalahan kefarmasian di pemerintahan. Praktek kerja ini dilakukan selama 3 minggu. Peran, tugas dan tanggung jawab Apoteker di Suku Dinas Kesehatan Kota Administrasi Jakarta Timur antara lain yaitu melakukan kegiatan Binwasdal, mengelolaan perbekalan farmasi obat program, vaksin, dan obat buffer , melakukan pendampingan perizinan apotek, dan merekapitulasi pelaporan pelaporan narkotika dan psikotropika, pelaporan LPLPO, Pelaporan Obat Rasional POR dan lainnya . Selama praktik kerja, tugas khusus yang diberikan adalah evaluasi pelaporan narkotika dan psikotropika periode Maret-April 2018 di Jakarta Timur.
