Praktik Kerja Profesi Apoteker di periode bulan Februari tahun 2018 dilaksanakan di fasilitas pelayanan kefarmasian, yaitu Apotek Kimia Farma No. 95 Bumi Serpong Damai. Tujuan dilaksanakannya praktek kerja profesi di apotek sebagai salah satu pelayanan kefarmasian adalah agar mahasiswa calon apoteker dapat memahami tugas dan tanggung jawab apoteker dalam apotek serta melakukan praktik kefarmasian yang sesuai dengan undang-undang dan etika. Selain itu, mahasiswa calon apoteker juga dapat memiliki pengalaman dan keterampilan dalam melakukan praktik kefarmasian, serta mengetahui permasalahan apotek yang terjadi. Diharapkan, mahasiswa nantinya dapat memiliki keterampilan untuk mengatasi dan menghindari permasalahan guna memperlancar praktik kefarmasian. Praktik kerja profesi dilakukan selama satu bulan dengan tugas khusus yaitu "Analisis Resep Penyakit Epilepsi di Apotek Kimia Farma No. 95". Tujuan dari tugas khusus ini adalah agar mahasiswa calon apoteker mampu mengkaji rasionalitas resep obat penyakit epilepsi yang ada di Apotek Kima Farma No. 95 berdasarkan aspek pengkajian administratis, farmasetik, dan klinis sesuai dengan perundang-undangan. Selain itu, mahasiswa juga diharapkan dapat memahami alur pengkajian resep yang sesuai dengan standar pelayanan kefarmasian di apotek.

ABSTRACT

Internship in February 2018 period was done at one of pharmaceutical services facility, which was Kimia Farma 95 Pharmacy at Bumi Serpong Damai. The purpose of doing an internship in pharmacy as one of a pharmaceutical services facility is for student to understand a pharmacist duties and responsibilities in a pharmacy, as well as performing a pharmaceutical services that based on law and professional ethics. Also, internship is required for a designated pharmacist to have field experiences and skills in performing a pharmaceutical services, and understanding problems in professional work which is happening on daily-basis. A designated pharmacist is expected to have a skills to resolve and evade those problems with expectations to give a good pharmaceutical practice at pharmacy based on standard law which is applicable in Indonesia. Internship was done for a month with special assignment "Prescription Analysis for Epilepsy-Diagnosed Patients at Kimia Farma 95 Pharmacy". The purpose of doing special assignment is so a pharmacist student could possess a skill in reviewing prescriptions, so they could identify and find problems in rational drug use for anti seizure drugs for epilepsy patients at Kimia Farma 95 Pharmacy. The review was done based on applicable standard law, which is administrative, pharmaceutical, and clinical reviews. Also, a designated pharmacist is expected to understand prescription's service flow which based on standard of pharmaceutical services at a pharmacy.
