### Abstrak

Apotek merupakan tempat dilaksanakannya praktik kefarmasian oleh Apoteker. Dalam melaksanakan praktik kefarmasian, Apoteker diwajibkan untuk mampu mengelola sediaan farmasi, alat kesehatan, dan bahan medis habis pakai serta memberikan pelayanan farmasi klinik sesuai dengan standar pelayanan kefarmasian di Apotek. Melihat urgensi tersebut, calon Apoteker diharapkan dapat memahami tugas dan tanggung jawab Apoteker dalam mengelola Apotek serta memiliki pengetahuan dan ketrampilan dalam melaksanakan praktik kefarmasian di Apotek sesuai peraturan perundang-undangan dan etika yang berlaku.
