Abstrak

PT. Kimia Farma Trading & Distribution (KFTD) merupakan perusahaan Badan Usaha Milik Negara (BUMN) yang berperan dalam penyaluran dan perdagangan perbekalan farmasi yang meliputi alat kesehatan, obat dan kosmetik, serta cold chain product (CCP) dari produk Kimia Farma dan berbagai produk prinsipal rekanan. CCP adalah rantai pasokan barang sensitif yang dikontrol oleh suhu, sehingga memerlukan perlakuan khusus dalam proses penyimpanan dan penyalurannya. Laporan ini bertujuan mengevaluasi kesesuaian implementasi standar operational procedure (SOP) terhadap proses penyimpanan dan penyaluran cold chain product di PT. KFTD Jakarta 3. Evaluasi dilakukan dengan membandingkan hasil observasi langsung kegiatan penyimpanan dan penyaluran CCP dengan elemen SOP penyimpanan dan penyaluran di PT. KFTD Jakarta 3 menggunakan form checklist. Berdasarkan hasil evaluasi, pelaksanaan penyimpanan dan penyaluran CCP di PT. KFTD Jakarta 3 telah dilakukan sesuai dengan SOP penyimpanan dan penyaluran serta termasuk ke dalam kategori baik

.....PT. Kimia Farma Trading & Distribution (KFTD) is a State-Owned Enterprise (BUMN) company whose role is in the distribution and trading of pharmaceutical supplies which include medical devices, medicines and cosmetics, as well as cold chain products (CCP) from Kimia Farma products and various products from principal partners. CCP is a temperature-controlled supply chain of sensitive goods, thus requiring special treatment in the storage and distribution process. This report aimed to evaluate the suitability of the implementation of the standard operational procedure (SOP) for the process of storing and distributing cold chain products at PT. KFTD Jakarta 3. The evaluation was carried out by comparing the results of direct observation of CCP storage and distribution activities with SOP elements for storage and distribution at PT. KFTD Jakarta 3 used a checklist form. Based on the evaluation results, the storage and distribution of CCP at PT. KFTD Jakarta 3 had been carried out in accordance with the SOP for storage and distribution and is included in the good category
