

## Alur Distribusi Barang di Kimia Farma Trading and Distribution Cabang Jakarta 2 = Flow of Goods Distribution at Kimia Farma Trading and Distribution Jakarta Branch 2

### Abstrak

Pedagang Besar farmasi adalah perusahaan berbentuk badan hukum yang memiliki izin untuk pengadaan, penyimpanan, penyaluran obat dan/atau bahan obat dalam jumlah besar sesuai ketentuan peraturan perundang-undangan. PBF Cabang adalah cabang PBF yang telah memiliki pengakuan untuk melakukan pengadaan, penyimpanan, penyaluran obat, dan /atau bahan obat dalam jumlah besar sesuai ketentuan peraturan perundang-undangan (Kemenkes RI, 2011). Kimia Farma Trading and Distribution (KFTD) merupakan anak perusahaan dari PT Kimia Farma yang bergerak di bidang layanan distribusi dan perdagangan produk Kesehatan di seluruh Indonesia. KFTD mendistribusikan obat, alat kesehatan, dan kosmetik kepada pelanggan sesuai perundang-undangan meliputi rumah sakit, klinik, PBF lain, apotek, dan toko obat. Alur distribusi barang di KFTD berawal sejak barang diproduksi di produsen. Barang-barang yang diproduksi kemudian disimpan di NDC, setelah itu barang akan disalurkan ke KFTD Cabang Jakarta 2 yang nantinya akan disalurkan ke pelanggan. Barang-barang yang diterima di KFTD cabang akan masuk melalui transit di gudang. Penanggungjawab logistik akan memeriksa kesesuaian barang yang datang dengan faktur yang sampai. Hal-hal yang diperiksa diantaranya adalah pengirim, jenis barang, jumlah barang, ED barang dan nomor bets barang yang dipesan. Setelah pemeriksaan selesai dan barang yang diterima sesuai maka selanjutnya stok barang akan dimasukkan ke dalam sistem. Setelah stok di sistem telah diperbarui, maka barang akan masuk ke bagian gudang yang telah ditentukan. Berikut merupakan skema pendistribusian barang di KFTD Jakarta 2 Kegiatan alur distribusi di PBF KFTD Cabang Jakarta 2 dari penerimaan barang hingga pelaporan barang sudah sesuai dengan perundang-undangan yang berlaku.

.....Pharmaceutical Wholesalers are companies in the form of legal entities that have permits to procure, store, distribute drugs and/or drug substances in large quantities in accordance with statutory provisions. PBF Branch is a PBF branch that has the recognition to procure, store, distribute drugs and/or drug substances in large quantities in accordance with statutory provisions (Ministry of Health RI, 2011). Kimia Farma Trading and Distribution (KFTD) is a subsidiary of PT Kimia Farma which is engaged in the distribution and trading services of health products throughout Indonesia. KFTD distributes drugs, medical devices and cosmetics to customers in accordance with laws and regulations, including hospitals, clinics, other PBFs, pharmacies and drugstores. The distribution flow of goods at KFTD begins when goods are produced at the manufacturer. The goods produced are then stored at the NDC, after which the goods will be distributed to KFTD Jakarta 2 Branch which will later be distributed to customers. Goods received at the KFTD branch will enter through transit in the warehouse. The person in charge of logistics will check the conformity of the incoming goods with the invoice that arrives. The things examined include the sender, type of goods, quantity of goods, ED of goods and batch number of goods ordered. After the inspection is complete and the goods received are appropriate, then the stock of goods will be entered into the system. After the stock in the system has been updated, the goods will enter the specified warehouse section. The following is a scheme for distributing goods at KFTD Jakarta 2 Distribution channel activities at PBF KFTD
