### Abstrak

Berdasarkan Standar Pelayanan Kefarmasian di Puskesmas No. 74 Tahun 2016, Puskesmas memiliki tanggung jawab dalam dalam kegiatan manajerial Pengelolaan Sediaan Farmasi dan Bahan Medis Habis Pakai serta Pelayanan Farmasi Klinik. Salah satu kegiatan pelayanan farmasi klinik yaitu memberikan Pelayanan Informasi Obat (PIO) (Kemenkes RI, 2016). Pelayanan Informasi Obat (PIO) adalah kegiatan yang dilakukan oleh apoteker untuk memberikan informasi secara akurat, jelas dan terkini kepada dokter, apoteker, perawat, profesi kesehatan lainnya serta pasien dan pihak lain di luar puskesmas (Kemenkes RI, 2019). Pelaksanaan pelayanan informasi obat di Puskesmas salah satunya dapat dilakukan dengan membuat leaflet serta melakukan kegiatan penyuluhan khususnya bagi pasien rawat jalan, rawat inap serta masyarakat (Kemenkes RI, 2016). Kegiatan tersebut telah rutin dilakukan di Puskesmas Kecamatan Palmerah. Peran apoteker dalam memberikan Pelayanan Informasi Obat di Puskesmas Kecamatan Palmerah yaitu menjawab pertanyaan terkait obat serta melakukan penyuluhan dan pembuatan leaflet secara akurat, jelas, dan terkini kepada pasien, tenaga kesehatan, dan masyarakat. Informasi terkait Interaksi Obat dan Makanan telah disampaikan dengan baik dan jelas melalui Penyuluhan dan Leaflet kepada pasien di Ruang Tunggu Apotek Puskesmas Kecamatan Palmerah.

Based on Pharmaceutical Service Standards at Health Center No. 74 of 2016, Community Health Centers have responsibility for managerial activities in the Management of Pharmaceutical Supplies and Medical Consumables and Clinical Pharmacy Services. One of the clinical pharmacy service activities is providing Drug Information Services (PIO) (Ministry of Health Republic of Indonesia, 2016). Drug Information Service (PIO) is an activity carried out by pharmacists to provide accurate, clear and up-to-date information to doctors, pharmacists, nurses, other health professionals as well as patients and other parties outside the puskesmas (RI Ministry of Health, 2019). The implementation of drug information services at the Community Health Center can be done by making leaflets and conducting outreach activities, especially for outpatients, inpatients and the community (Ministry of Health Republic of Indonesia, 2016). This activity has been routinely carried out at the Palmerah District Health Center. The role of the pharmacist in providing Drug Information Services at the Palmerah District Health Center is to answer questions related to drugs and conduct counseling and produce leaflets in an accurate, clear and up-to-date manner for patients, health workers and the community. Information related to drug and food interactions has been conveyed properly and clearly through counseling and leaflets to patients in the waiting room of the Palmerah Health Center Pharmacy.
