

# Evaluasi Pengawasan Importasi Barang Dalam Perspektif Intelijen Strategis : Studi Kasus di Kantor Pelayanan Utama Bea dan Cukai Tipe A Tanjung Priok = The Evaluation of Control on Imported Goods in Strategic Intelligence Perspective : A Case Study of Prime Customs and Excises Office Type A Tanjung Prio

## Abstrak

Penelitian ini dilatarbelakangi adanya potensi kerentanan pengawasan importasi barang akibat vitalnya posisi pelabuhan Tanjung Periok pada perdagangan internasional Indonesia. Kerentanan yang timbul membutuhkan evaluasi pengawasan yang dilakukan dari sudut pandang intelijen strategis untuk perbaikan kinerja pengawasan di masa yang akan datang. Menggunakan pendekatan kualitatif, penelitian ini menggunakan data dari hasil wawancara terhadap sejumlah narasumber yang terkait dengan aktivitas importasi barang di Pelabuhan Tanjung Priok. Hasil penelitian menunjukkan pengawasan yang dilakukan belum sepenuhnya menerapkan pendekatan intelijen strategis pada pengawasan importasi barang. Kendala utama yang menjadi penghalang adalah keterbatasan sumber daya baik faktor manusia dan teknologi pendukungnya. Disamping itu, metode yang digunakan dalam mengelola data intelijen dan kebijakan yang mengatur aktifitas intelijen juga menjadi penghambat kinerja intelijen Bea dan Cukai di Tanjung Priok memaksimalkan tugas dan fungsi Revenue collector, Communicaty protection, Trade facilitator dan Industrial Assistance. .....This research is motivated by the potential vulnerability of monitoring the import of goods due to the vital position of the Tanjung Periok port in Indonesia's international trade. The vulnerabilities that arise require an evaluation of supervision carried out from the perspective of strategic intelligence to improve supervisory performance in the future. Using a qualitative approach, this study uses data from interviews with a number of informants related to the activity of importing goods at the Port of Tanjung Priok. The results of the study show that the supervision carried out has not fully implemented the strategic intelligence approach in controlling the import of goods. The main obstacle that becomes a barrier is the limited resources of both the human factor and its supporting technology. In addition, the methods used in managing intelligence data and policies governing intelligence activities also hinder the performance of Customs and Excise intelligence at Tanjung Priok in maximizing the duties and functions of Revenue collector, Communication protection, Trade facilitator and Industrial Assistance.
