### Abstrak

Praktik Kerja Profesi Apoteker merupakan salah satu persyaratan bagi mahasiswa Program Studi Apoteker untuk mendapatkan gelar profesi. Praktik Kerja ini dilakukan di lima instansi yang berbeda agar lulusan apoteker mengetahui apa yang akan dikontribusikan setelah mendapatkan gelar mereka dan mendapatkan pengalaman kerja di bidang farmasi. Praktik Kerja dilakukan selama delapan bulan, Maret 2022 sampai Oktober 2022. Pada Maret 2022 bertempat di Suku Dinas Kesehatan Jakarta Selatan dengan Tugas Khusus dengan topik utama SIPNAP. Pada April 2022 dilakukan di PT SamMarie Tramedifa yang merupakan Pedagang Besar Farmasi dengan topik Tugas Khusus Distribusi Sediaan Farmasi di PBF. Selanjutnya dari Mei-Juni 2022 dilaksanakan di RSUI dengan topik Tugas Khusus Pemusnahan Obat-obat Tertentu, Prekursor, Psikotropika, dan Narkotika. Tempat selanjutnya adalah Apotek Kimia Farma 382 di Bulan Agustus 2022 dengan topik Tugas Khusus Perencanaan Pengadaan Sediaan Farmasi. Tempat terakhir PKPA pada Bulan September-Oktober 2022 di PT CKD-Otto Pharmaceuticals, Industri Farmasi, dengan topik Tugas Khusus Kualifikasi Desain di Industri Farmasi. Penulis telah berhasil melaksanakan PKPA dengan baik di tempat-tempat yang telah disebutkan. Selama melakukan PKPA banyak sekali pengetahuan dan pengalaman yang didapatkan.

..... Pharmacist Professional Work Practice is one of the requirements for Pharmacist Study Program students to obtain a professional degree. This work practice is carried out in five different institutions so that pharmacist graduates know what they will contribute after getting their degree and gaining work experience in the pharmaceutical field. Work Practices will be carried out for eight months, March 2022 to October 2022. In March 2022, they will be held at the South Jakarta Health Sub-Department with the main topic of Special Task is SIPNAP. In April 2022 it was held at PT SamMarie Tramedifa which is a Pharmaceutical Wholesaler with the topic of Special Tasks for Distribution of Pharmaceutical Preparations at PBF. The final place for PKPA will be in September-October 2022 at PT CKD-Otto Pharmaceuticals, a Pharmaceutical Industry, with the topic of Special Task is Design Qualification in the Pharmaceutical Industry.
