Abstrak

Praktik Kerja Profesi Apoteker (PKPA) di instansi Distributor dilaksanakan pada Kimia Farma Trading & Distribution Jakarta 3 pada bulan November tahun 2022. Adapun kegiatan PKPA di instansi distributor bertujuan untuk pembelajaran dan memahami peran serta tanggung jawab seorang apoteker melingkupi pada ruang lingkup distributor. Pada pelaksanaan PKPA di distributor, dilakukan penyusunan laporan tugas khusus terkait pengkajian penanganan produk rantai dingin serta produk retur pada Kimia Farma Trading & Distribution Jakarta 3. Kegiatan tersebut bertujuan untuk mengkaji penanganan produk rantai dingin meliputi kegiatan penerimaan, penyimpanan, penyaluran, bangunan dan fasilitas. Pengkajian mengacu kepada pedoman Cara Distribusi Obat yang Baik (CDOB). Berdasarkan pengkajian yang telah dilakukan, terkait aspek penerimaan, penyimpanan, penyaluran, bangunan dan fasilitas serta kalibrasi alat yang digunakan pada PT.Kimia Farma Trading & Distribution Jakarta 3 telah sesuai dengan pedoman Cara Distribusi Obat yang Baik (CDOB).

.....Pharmacist Professional Work Practice (PKPA) at the Distributor institution was held at Kimia Farma Trading & Distribution Jakarta 3 in November 2022. The PKPA activities at the pharmacy agency aim to learn and understand the roles and responsibilities of a pharmacist in the scope of the distributor. In the implementation of PKPA at the distributor, a report was prepared related to the assessment of cold chain product handling and returned products at Kimia Farma Trading & Distribution Jakarta 3. The activity aims to assess the handling of cold chain products including receiving, storage, distribution, buildings and facilities. The assessment refers to the guidelines for Good Distribution Practice (GDP). Based on the assessment that has been carried out, related aspects of receiving, storage, distribution, buildings and facilities and calibration of equipment used at PT Kimia Farma Trading & Distribution Jakarta 3 are in accordance with the guidelines for Good Distribution Practice (GDP).
