

# Pelaksanaan Rehabilitasi Sosial Pada Anak Penyintas Kekerasan Seksual (Studi Deskriptif di Rumah Faye Batam) = Implementation of Social Rehabilitation for Child Survivors of Sexual Violence (Descriptive Study at Rumah Faye Batam)

## Abstrak

Penelitian ini dilatarbelakangi dengan tingginya angka kasus kekerasan seksual pada anak di Kota Batam. Upaya lembaga pemerintah dan non-pemerintah dalam perlindungan anak korban kekerasan seksual adalah dengan menyediakan layanan rehabilitasi sosial. Rumah Faye salah satu lembaga independen di Indonesia berfokus isu perlindungan anak menyelenggarakan rehabilitasi sosial sebagai upaya pemenuhan hak anak korban kekerasan seksual. Rumah Faye mendirikan Rumah Aman (Shelter) dijadikan sebagai rumah perlindungan dan tempat tinggal sementara bagi anak korban kekerasan seksual. Tujuan dari penelitian ini adalah untuk mendeskripsikan pelaksanaan rehabilitasi sosial pada anak penyintas kekerasan seksual di Rumah Faye serta hambatan-hambatan yang dihadapi selama pelaksanaan rehabilitasi sosial di Rumah Faye. Penelitian dilakukan pada bulan Maret hingga Desember 2023. Penelitian ini menggunakan pendekatan kualitatif dengan jenis penelitian deskriptif. Teknik pengumpulan data melalui wawancara mendalam dan studi literatur. Terdapat 6 informan yang terlibat dalam penelitian ini terdiri dari 1 Manajer Program Pusat, 1 General Supervisor, 2 staf pendamping, dan 2 penerima manfaat. Hasil penelitian menunjukkan bahwa pelaksanaan rehabilitasi sosial di Rumah Faye dimulai dari penerimaan pengaduan, identifikasi awal, rencana intervensi dan pelaksanaan intervensi yang berlangsung di Rumah Aman (Shelter). Adapun pada tahap reintegrasi sosial terdiri dari reunifikasi/pemulangan, monitoring dan terminasi. Hambatan yang dihadapi dalam pelaksanaan terdiri dari (1) hambatan internal: kondisi penerima manfaat, anggaran lembaga, sarana dan fasilitas lembaga; (2) hambatan eksternal: keluarga, aparat hukum, stakeholder dan jaringan.

.....This research was motivated by the high number of cases of sexual violence against children in Batam City. The efforts of government and non-government institutions to protect child victims of sexual violence are by providing social rehabilitation services. Rumah Faye, one of the independent institutions in Indonesia, focuses on child protection issues and organizes social rehabilitation as an effort to fulfill the rights of children who are victims of sexual violence. Rumah Faye established a safe house or shelter to serve as a safe house and temporary residence for child victims of sexual violence. The aim of this research is to describe the implementation of social rehabilitation for child survivors of sexual violence at Rumah Faye and the obstacles faced during the implementation of social rehabilitation at Rumah Faye. The research was conducted from March to December 2023. This research used a qualitative approach with descriptive research type. Data collection techniques through in-depth interviews and literature studies. There were 6 informants involved in this research consisting of 1 Central Program Manager, 1 General Supervisor, 2 accompanying staff, and 2 beneficiaries. The research results show that the implementation of social rehabilitation at Rumah Faye starts from receiving complaints, initial identification, intervention planning and implementation of interventions that take place in the Safe House (Shelter). The social reintegration stage consists of reunification/repatriation, monitoring and termination. Obstacles faced in implementation

consist of (1) internal obstacles: condition of beneficiaries, institutional budget, institutional facilities and equipment; (2) external barriers: family, legal apparatus, stakeholders and networks.
