Abstrak

Saat ini standar pelayanan kefarmasian di apotek ditetapkan dengan Permenkes Nomor 73 Tahun 2016, yang merupakan tolak ukur yang dipergunakan sebagai pedoman bagi tenaga kefarmasian dalam menyelenggarakan pelayanan kefarmasian. Penelitian ini dilakukan di Apotek Kimia Farma Tigaraksa dengan tujuan untuk mengkaji dan melakukan studi literatur mengenai implementasi pengelolaan sediaan farmasi di apotek berdasarkan Permenkes No. 73 tahun 2016, untuk melihat apakah pengelolaan sediaan farmasi yang diterapkan di Apotek Kimia Farma Tigaraksa sudah baik dan sesuai dengan Permenkes No. 73 tahun 2016 mengingat bahwa apotek tersebut baru berdiri selama 2 tahun. Penelitian ini merupakan penelitian deskriptif observatif, dilakukan dengan fase survei, dilanjutkan fase observasi dan wawancara mendalam. Hasil penelitian diperoleh, berdasarkan survei pelaksanaan pengelolaan sediaan farmasi, alkes dan BMHP dilakukan oleh apoteker dibantu TTK. Pengelolaan perbekalan farmasi di Apotek Kimia Farma Tigaraksa sudah sesuai dengan Peraturan Menteri Kesehatan No. 73 Tahun 2016 yang meliputi serangkaian kegiatan yang berkesinambungan yaitu perencanaan, pengadaan, penerimaan, penyimpanan, pemusnahan, pencatatan dan pelaporan.

Currently, the standards for pharmaceutical services in pharmacies are determined by Minister of Health Regulation Number 73 of 2016, which is a benchmark used as a guide for pharmaceutical personnel in providing pharmaceutical services. This research was conducted at Kimia Farma Tigaraksa Pharmacy with the aim of reviewing and conducting a literature study regarding the implementation of pharmaceutical preparation management in pharmacies based on Minister of Health Regulation No. 73 of 2016, to see whether the management of pharmaceutical preparations implemented at Kimia Farma Tigaraksa Pharmacy is good and in accordance with Minister of Health Regulation No. 73 of 2016 considering that the pharmacy has only been established for 2 years. This research is an observational descriptive research, carried out with a survey phase, followed by an observation phase and in-depth interviews. The research results were obtained based on a survey of the implementation of management of pharmaceutical preparations, medical equipment and BMHP carried out by pharmacists assisted by TTK. Management of pharmaceutical supplies at Kimia Farma Tigaraksa Pharmacy is in accordance with Minister of Health Regulation no. 73 of 2016 which includes a series of continuous activities, namely planning, procurement, receipt, storage, destruction, recording and reporting.
