Abstrak

Permasalahan umum yang biasanya terjadi dalam pelayanan di puskesmas adalah berlebih atau kurangnya stok obat dan adanya obat rusak atau kadaluarsa yang masih ditemukan di gudang penyimpanan obat. Masalah ini kerap muncul karena dipengaruhi oleh sistem pengelolaan obat di puskesmas yang kurang baik. Beberapa hasil penelitian juga menunjukkan bahwa pengelolaan obat yang terkait perencanaan dan pendistribusian obat sudah memenuhi standar pengelolaan obat di puskesmas, tetapi pengadaan dan penyimpanan obat kurang baik dan tidak sesuai dengan pedoman pengelolaan obat yang ada. Penelitian ini dilakukan di Puskesmas Pasar Rebo dengan tujuan untuk acuan dan referensi bagi instalasi farmasi PKC Pasar Rebo dalam melakukan pengelolaan sediaan farmasi. Penelitian ini dilakukan menggunakan metode deskriptif observational. Jenis data yang digunakan bersifat narasi, uraian serta penjelasan data dari informan baik lisan maupun perilaku subjek yang diamati di lapangan. Pedoman pengelolaan sediaan farmasi dan BMHP PKC Pasar Rebo dibuat berdasarkan Petunjuk Teknis Standar Pelayanan Kefarmasian di Puskemas yang diterbitkan oleh kemenkes serta peraturan per-undang-undangan yang diterbitkan baik oleh kemenkes, presiden maupun pemerintah daerah setempat.

Common problems that usually occur in services at community health centers are excess or insufficient stock of medicines and the presence of damaged or expired medicines that are still found in medicine storage warehouses. This problem often arises because it is influenced by the poor drug management system at the community health center. Several research results also show that drug management related to planning and distribution of drugs meets drug management standards at community health centers, but drug procurement and storage are poor and do not comply with existing drug management guidelines. This research was conducted at the Pasar Rebo Community Health Center with the aim of being a reference and reference for the PKC Pasar Rebo pharmaceutical installation in managing pharmaceutical supplies. This research was conducted using descriptive observational methods. The type of data used is narrative, description and explanation of data from informants both verbally and subject behavior observed in the field. Guidelines for the management of pharmaceutical preparations and BMHP PKC Pasar Rebo were created based on the Technical Instructions for Pharmaceutical Service Standards at Community Health Centers issued by the Ministry of Health as well as statutory regulations issued by the Ministry of Health, the president and the local government.
