

Pengkajian Kesesuaian Aspek Operasional CDOB di PBF PT Masiva Guna = Assessment of Compatibility of Operational Aspect CDOB at Distributor PT Masiva Guna

Abstrak

Distribusi sediaan farmasi merupakan kegiatan menyalurkan sediaan farmasi kepada fasilitas kesehatan. Kegiatan ini dilakukan oleh distributor yang memiliki izin distribusi. Pedagang besar farmasi adalah salah satu unit terpenting dalam kegiatan penyaluran sediaan farmasi ke fasilitas kesehatan seperti apotek, instalasi farmasi rumah sakit, puskesmas, klinik dan toko obat agar dapat sampai ke tangan masyarakat. Apoteker sebagai penanggung jawab distributor farmasi harus mampu melakukan kegiatan pengelolaan sediaan farmasi yaitu pengadaan, penyimpanan, dan pendistribusian sediaan farmasi ke sarana pelayanan kesehatan. Pada laporan praktik ini, akan dibahas mengenai kesesuaian aspek operasional Cara Distribusi Obat yang Baik di PT. Masiva Guna. Metode pengkajian yang dilakukan untuk menyusun laporan ini adalah dengan melakukan pengamatan secara langsung kegiatan operasional di Pedagang Besar Farmasi dan menggali informasi kepada Apoteker Penanggung Jawab dan Staff di PT. Masiva Guna. Berdasarkan pengkajian terdapat beberapa aspek yang belum terlaksana seperti belum tersedianya sistem yang menjamin first in first out/ first expired first out pada sediaan farmasi, namun sudah dilakukan sosialisasi kepada staff untuk tetap memeriksa tanggal expired sediaan farmasi. Selain itu, obat yang tidak layak jual suda dipisahkan dan disimpan di tempat terpisah namun tidak terkunci, tetapi sudah ada penandaan berupa label yang jelas untuk mencegah tersalurnya obat tidak layak jual kepada masyarakat.

..... Distribution of pharmaceutical preparations is the activity of distributing pharmaceutical preparations to health care facilities. This activity is carried out by distributors who have distribution permits.

Pharmaceutical wholesalers are one of the most important units in the distribution of pharmaceutical supplies to health facilities such as pharmacies, hospital pharmaceutical installations, health centers, clinics and drug stores so that they can reach the hands of the public. Pharmacists as those responsible for pharmaceutical distributors must be able to carry out pharmaceutical preparation management activities, such as procurement, storage and distribution of pharmaceutical preparations to health care facilities. In this practice report, we will discuss the suitability of operational aspects of Good Distribution Practice Methods at PT. Masiva Guna. The assessment method used to prepare this report is by directly observing operational activities at Pharmaceutical Wholesalers and gathering information from the Pharmacist in Charge and Staff at PT. Masiva Guna. Based on the study, there are several aspects that have not been implemented, such as the lack of a system that guarantees first in first out/first expired first out on pharmaceutical preparations, however outreach has been carried out to staff to continue checking the expiry date of pharmaceutical preparations. Apart from that, medicines that are not fit for sale have been separated and stored in a separate place but are not locked, but there are signs in the form of clear labels to prevent distribution of drugs that are not fit for sale to the public.
