Abstrak

Distribusi obat harus memenuhi aspek yang tercantum pada Cara Distribusi Obat yang Baik (CDOB) agar obat dapat ditangani dengan baik untuk menghindari kerusakan atau penyalahgunaan obat. Narkotika, Psikotropika, Prekursor dan Obat-obat Tertentu (OOT) merupakan produk obat yang dapat menyebabkan kecanduan sehingga berpotensi tinggi untuk disalahgunakan diluar tujuan medis. Diperlukan juga adanya dokumentasi, pencatatan dan pelaporan yang berfungsi untuk memonitor transaksi sediaan farmasi yang keluar dan masuk di PBF. Adanya dokumentasi, pencatatan, dan pelaporan dapat memudahkan dalam melakukan penelusuran bila terjadi adanya mutu sediaan dan harus ditarik dari peredaran. Berdasarkan penjelasan di atas, penulis akan membahas tentang Implementasi Standar Operasional Prosedur (SOP) dokumentasi, pencatatan, dan pelaporan obat narkotika, psikotropika, prekursor dan OOT di PT Kimia Farma Trading and Distribution Jakarta 2 dengan metode observasi dan wawancara kepada Apoteker Penanggung Jawab dan Petugas. Berdasarkan hasil pengamatan dan analisis implementasi Standar Operasional Prosedur (SOP) dokumentasi, pencatatan, dan pelaporan narkotika, psikotropika, prekursor dan OOT di PT Kimia Farma Trading & Distribution (KFTD) Jakarta 2 telah memenuhi standar Cara Distribusi Obat yang Baik (CDOB) dan telah dilaksanakan sesuai dengan Standar Operasional Prosedur (SOP) yang berlaku.

Medicine distribution must fulfill the aspects listed in Good Medicine Distribution Practices (CDOB) so that medicines can be handled properly to avoid damage or misuse of medicines. Narcotics, Psychotropics, Precursors and Certain Drugs (OOT) are medicinal products that can cause addiction so they have a high potential for abuse for other than medical purposes. There is also a need for documentation, recording and reporting which functions to monitor transactions of pharmaceutical preparations coming in and out of the PBF. The existence of documentation, recording and reporting can make it easier to carry out investigations if there is a problem with the quality of the preparation and it must be withdrawn from circulation. Based on the explanation above, the author will discuss the implementation of Standard Operating Procedures (SOP) for documentation, recording and reporting of narcotic drugs, psychotropics, precursors and OOT at PT Kimia Farma Trading and Distribution Jakarta 2 using observation and interview methods with Responsible Pharmacists and Officers. . Based on the results of observations and analysis of the implementation of Standard Operating Procedures (SOP), documentation, recording and reporting of narcotics, psychotropics, precursors and OOT at PT Kimia Farma Trading & Distribution (KFTD) Jakarta 2 has met the standards for Good Drug Distribution Methods (CDOB) and has carried out in accordance with applicable Standard Operating Procedures (SOP).
