

## Evaluasi Pelatihan Audit Infrastruktur bagi Auditor di Badiklat Pemeriksaan Keuangan Negara BPK RI = Evaluation of Infrastructure Audit Training for Auditors at the BPK RI Training Institute of State Financial Audit

### Abstrak

Laporan Praktik Keinsinyuran ini membahas evaluasi pelatihan audit infrastruktur yang dilaksanakan di BPK RI. Pembahasan dilakukan untuk mengetahui tingkat kepuasan peserta terhadap penyelenggaraan pelatihan, materi pelatihan, fasilitator pelatihan, perubahan pemahaman peserta, serta penerapan Keselamatan dan Kesehatan Kerja dalam materi pelatihan audit infrastruktur. Laporan Praktik Keinsinyuran ini menggunakan metode analisis kuesioner berdasarkan Kirkpatrick Evaluation Model level 1 dan level 2 serta analisis deskriptif atas penerapan materi Keselamatan dan Kesehatan Kerja. Berdasarkan hasil penelitian, dapat disimpulkan bahwa kepuasan peserta pelatihan terhadap penyelenggaraan pelatihan, materi pelatihan, dan fasilitator pelatihan sangat tinggi serta terdapat peningkatan pemahaman materi pelatihan audit infrastruktur. Terkait dengan penguatan materi Keselamatan dan Kesehatan Kerja khususnya mutu konstruksi, masih terdapat hal-hal yang perlu disempurnakan, antara lain percepatan pembangunan Taman Infrastruktur sebagai media praktik lapangan dan memperbanyak studi kasus mengenai keselamatan konstruksi khususnya audit mutu konstruksi.

This Practice Report discusses the evaluation of infrastructure audit training carried out at the BPK RI. The discussion was carried out to determine the level of participant satisfaction with the training implementation, training materials, training facilitators, changes in participants' understanding, as well as the application of Occupational Safety and Health in infrastructure audit training materials. This Practice Report uses a questionnaire analysis method based on the Level 1 and Level 2 Kirkpatrick Evaluation Model as well as descriptive analysis of the application of Occupational Safety and Health material. Based on the research results, it can be concluded that training participants' satisfaction with the training organization, training materials and training facilitators is very high and there is an increase in understanding of infrastructure audit training materials. Regarding strengthening Occupational Safety and Health material, especially construction quality, there are still things that need to be improve, including accelerating the development of Infrastructure Parks as a medium for field practice and increasing number of case studies regarding construction safety, especially construction quality audits.
