## Abstrak

Pemerintah telah membuat suatu peraturan mengenai Cara Distribusi Obat yang Baik (CDOB) tahun 2012 tentang Pedoman Teknis Cara Distribusi Obat Yang Baik. PT. Kimia Farma Trading & Distribution merupakan salah satu PBF dibawah naungan BUMN dengan tujuan melakukan pengadaan, penyimpanan, penyaluran obat dan/atau bahan obat dalam jumlah besar sesuai ketentuan peraturan perundang-undangan. Tugas khusus ini menganalisis hasil dari implementasi cara distribusi obat yang baik terhadap inspeksi diri dan kententuan khusus CCP (Cold Chain Product) di PT. Kimia Farma Trading & Distribution. Penelitian dilakukan dengan menggunakan metode observasional yang bersifat deskriptif dan evaluatif dimana dilakukan analisis kesesuaian dengan CDOB dan evaluasi pada kegiatan yang sedang berjalan dengan metode CAPA (Corrective Action and Preventive Action). Berdasarkan hasil pengamatan implementasi Cara Distribusi Obat yang Baik (CDOB) pada inspeksi diri dan ketentuan khusus cold chain product (CCP) diketahui bahwa Kimia Farma Trading & Ditribution Jakarta 2 secara aktual sudah sesuai dan telah menerapkan seluruh aspek CDOB dengan baik.

The government has made a regulation regarding Good Medicine Distribution Methods (CDOB) in 2012 concerning Technical Guidelines for Good Medicine Distribution Methods. PT. Kimia Farma Trading & Distribution is one of the Pharmaceutical Wholesalers under the auspices of BUMN with the aim of procuring, storing, distributing medicines and/or medicinal ingredients in large quantities in accordance with statutory provisions. This task was to analyzes the results of implementing good drug distribution methods regarding selfinspection and special CCP (Cold Chain Product) provisions at PT. Kimia Farma Trading & Distribution. The research was carried out using observational methods which are descriptive and evaluative in nature where an analysis of conformity with CDOB and evaluation of ongoing activities was carried out using the CAPA (Corrective Action and Preventive Action) method. Based on the results of observations of the implementation of Good Medicine Distribution Methods (CDOB) in self-inspection and special cold chain product (CCP) provisions, it is known that Kimia Farma Trading & Distribution Jakarta 2 is actually in compliance and has implemented all aspects of CDOB well.
