## Abstrak

Badan Pengawas Obat dan Makanan (BPOM) telah menerbitkan Surat Edaran Kepala BPOM Nomor 5 Tahun 2023 tentang Pedoman Kualifikasi Pemasok Bahan Obat. Tujuan tugas khusus ini bertujuan untuk menganalisis kesenjangan (GAP) antara kualifikasi pemasok bahan obat menurut Surat Edaran Kepala BPOM Nomor 5 Tahun 2023 dan prosedur tetap di PT. CKD Otto Pharmaceuticals. Metode yang digunakan dalam pembuatan tugas khusus ini adalah metode observasional dengan design Cohort. The Food and Drug Supervisory Agency (BPOM) has issued Circular Letter from the Head of BPOM Number 5 of 2023 concerning Qualification Guidelines for Suppliers of Medicinal Ingredients. The purpose of this special assignment aims to analyze the gap (GAP) between the qualifications of medicinal ingredient suppliers according to the Circular Letter of the Head of BPOM Number 5 of 2023 and the permanent procedures at PT. CKD Otto Pharmaceuticals. The method used in making this special assignment was an observational method with a cohort design.
